- the personal data provided by the Entrant in the entry form or later during the Competition will be processed for the purpose of organizing and conducting the Competition, publishing information about the winners of the Competition and their works on the Organizers' websites and local Internet portals, at the exhibition of the competition entry projects as well as for archiving purposes and accountability required by the provisions of the General Data Protection Regulation,

- the Organisers process the indicated personal data on the basis of a legitimate interest which is to enable the Competition Entrants to take part in the Competition and to enable the Organisers to conduct the Competition, to publish information about the winners and to archive documents,

- the Organisers may provide contact data of the Competition winners obliged to pay advance payments of income tax on prizes in kind to the payer of this tax, i.e. the Founder of the prizes, in order to enable the Founder to collect and pay such advance payments in compliance with the provisions of art. 30 and art. 41, section 7 of the Personal Income Tax Act of 26 July 1991,

- individuals whose personal data are processed by the Organisers have the right to:

- have access to their personal data
- request the rectification of data which are inaccurate
- have your data erased if they are not necessary for the purposes for which they were collected or, after you have lodged an objection to the processing of your data, if they are processed unlawfully

- request the restriction of data processing, where these individuals question the accuracy of the data, the processing is unlawful and these individuals object to the erasure of the data, the Organisers no longer need the personal data for the purposes of the processing but they are needed by the individuals to whom the data refer to establish, pursue or defend claims or when the individuals have raised an objection to the processing of the data - until the controller's superior interests overriding the grounds for such objection are established
  - object to the processing of the data - for reasons related to the specific situation of the individuals whose data are processed - the provision of personal data is voluntary but necessary to enable the Organisers to organise the Competition and notify the winners of the prizes; in so far as it relates to the obligation to collect advance payments for income tax on the prizes awarded to the winner, the provision of the data is mandatory and it results from the aforementioned Personal Income Tax Act,
- the Organisers do not process the personal data of the competition entrants relying solely on automated processing, including profiling.
